### **PACKAGE OF INCENTIVES FOR INTERNATIONAL PARTICIPANTS**

For promoting exports from India, the organizers of India International Cooperatives Trade Fair (IICTF) hereby notify the following package of incentives for international participants who may be from COOPERATIVE / PRIVATE / CORPORATE / GOVERNMENT / INDIVIDUAL CATEGORIES. **Entry to the IICTF is free.** However, for setting up an exhibition space for business (as an exhibitor or buyer-exhibitor) or to take part in pre-arranged B2B meetings (as a visitor), online registration on [www.iictf.in](http://www.iictf.in) or on [www.iictf.co.in](http://www.iictf.co.in) is required. It is not necessary for an international buyer to set up an exhibition space and it may register as B2B meeting visitor.

The international participants (buyers / exhibitors / B2B meeting visitors) who register online on or before 31<sup>st</sup> August 2019 will be given **25% discount** on the publicized exhibition space/B2B meeting charges.

**For foreign buyers**, SPECIAL INCENTIVE OF COST SHARING THROUGH REIMBURSEMENT (ONLINE BANK TRANSFER) FOR MEETING ACTUAL COST OF ECONOMY CLASS TO AND FRO AIR FARE FROM INTERNATIONAL AIRPORT OF HOME COUNTRY TO IGI INTERNATIONAL AIRPORT, DELHI (NOT MORE THAN TWO BUYERS FROM A SINGLE ORGANIZATION) AND HOTEL CHARGES (NOT MORE THAN FOUR NIGHT STAYS DURING THE EVENT) AT NEW DELHI, SUBJECT TO A MAXIMUM AMOUNT PER BUYER AS INDICATED IN THE TABLE BELOW, SHALL BE CONSIDERED BY THE ORGANIZERS BASED ON PRODUCTION OF RECOMMENDATION FROM INDIAN EMBASSY / INDIAN CONSULATE CONCERNED OR FROM MEA / NEDAC.

1.	Countries with developed markets, for example, North America, Europe, North East Asia, Australia, New Zealand etc.	INR Thirty Seven Thousand And Five Hundred
